**Brussels, May 24<sup>th</sup>, 2018.** Public Safety Communication Europe, the European public safety Association, and 5G Infrastructure Association, representing the European industry in the 5G-PPP Research Programme, have signed a Cooperation agreement to foster collaboration on 5G development.

It is aimed at fostering industry-driven research, monitored by business-related, technological performance and societal KPIs. The 5G PPP will deliver solutions, architectures, technologies and standards for ubiquitous next-generation communication infrastructure over the coming decade.
